ORDERED that

1. Respondent Ram A. Prasad, D.V.M. shall have leave to and hereby does retract his previously entered plea of not guilty and enters a plea of no contest to the Complaint herein;
2. Respondent shall be and hereby is reprimanded;
3. Respondent shall within ten (10) days pay a fine of \$750.00 by means of a certified check payable to the State of New Jersey and submitted to the Board;
4. Respondent shall, within ten (10) days, pay to Mr. and Mrs. Michael Malawich restitution in the amount of \$279.75, to cover the
