IT IS ON THIS 17<sup>th</sup> DAY OF JANUARY, 1990,


ORDERED AND AGREED THAT:

1. A license to practice dentistry in the State of New Jersey shall forthwith be issued to Eugene Schlagel, D.D.S.,


with the following conditions:

- a. Dr. Schlager shall limit his practice in New Jersey to the practice of endodontics.
- b. Dr. Schlager shall obtain an Announcement of Practice in a Special Area of Dentistry (i.e. a Specialty Permit) in endodontics from the Board of Dentistry.

2. In the event that Dr. Schlager violates any of the provisions of this Order, the Attorney General may, on short notice, move before the Board for suspension or revocation of Dr. Schlager's license to practice dentistry or for any other relief as may be in the public interest.
