Administrative Action

CONSENT ORDER

This matter was opened to the State Board of Dentistry upon receipt of information concerning the prescription and/or recordkeeping of Schedule II Controlled Dangerous Substances for a patient in the dental practice of Dr. Jerrold Neeff. The Board reviewed the record in this matter including information received during the course of an inquiry attended by Dr. Neeff on January 3, 1990, together with his counsel, John Paul Dizzia, Esq. The settlement of this matter has been arrived at without express findings of unlawful conduct by the Board and without admission of wrongdoing by Dr. Neeff.

In order to settle this matter without recourse to formal proceedings and for good cause shown;

IT IS ON THIS 29th DAY OF AUGUST, 1990,

HEREBY ORDERED AND AGREED THAT:

1. Dr. Neeff agrees to be reprimanded by the Board for an incident of alleged improper prescribing of controlled dangerous substances and/or alleged improper recordkeeping for one patient in his dental practice.


2. Dr. Neeff voluntarily agrees to pay by way of settlement a civil penalty in the amount of Two Hundred and Fifty (\$250.00) Dollars for failure to comply with the requirements of N.J.A.C. 13:30-8.8 which provides the minimum standards for maintaining patient records. This penalty shall be paid by certified check or money order made payable to the State of New Jersey and submitted to William Gutman, Executive Director of the Board, 1100 Raymond Boulevard, Room 510, Newark, New Jersey 07102, within fifteen (15) days of the entry date of this Order.

3. Dr. Neeff voluntarily agrees to pay by way of settlement the costs to the State of New Jersey for the investigation of this case in the amount of Seven Hundred and Fifty (\$750.00) Dollars. Such costs shall be paid by certified check or money order made payable to the State of New Jersey and submitted to William Gutman within fifteen (15) days of the entry date of this Order.




