Administrative Action

CONSENT ORDER

This matter was opened to the New Jersey State Board of Dentistry upon receipt of a patient complaint from Linda M. Jones concerning the dental services Dennis Jackson, D.D.S. rendered to her including, in pertinent part, allegedly defective root canal therapy and a crown on tooth #31 resulting in the need for retreatment of the tooth. The Board reviewed the patient's records, including X-rays, and acquired further information at an investigative inquiry attended on May 20, 1992 by Dr. Jackson together with his counsel, Benjamin Kreitzberg, Esq.

It appearing that the parties wish to resolve this matter without recourse to formal proceedings and for good cause shown;

IT IS ON THIS 8th DAY OF ~~JUNE~~ JULY, 1992,

HEREBY ORDERED AND AGREED THAT:


1. Dr. Jackson shall make restitution for dental treatment on tooth #31 to the patient in the amount of \$125 and to the patient's insurance carrier in the amount of \$325. This restitution shall be paid by submitting a certified check or money order made payable to Linda M. Jones in the amount of \$125 and to Unity Health Service in the amount of \$325 to the State Board of Dentistry at 124 Halsey Street, Sixth Floor, Newark, New Jersey 07102 no later than the first day of the month following the entry date of this Order.

2. Dr. Jackson shall successfully complete fourteen (14) hours of continuing education in basic crown and bridge dentistry and seven (7) hours of continuing education in radiology. These courses shall be approved by the Board in writing prior to attendance and must be completed within six (6) months of the entry date of this Order. Dr. Jackson also shall be required to provide the Board with written proof of successful completion of the required course work.
