Order for
Reinstatement of
Licensure With Conditions

For Reinstatement of Licensure _____)

This matter was opened to the Board on the application for reinstatement of licensure by Evamarie Eskin, M.D. Dr. Eskin's license was voluntarily surrendered on February 8, 1995 for repeated instances of substance abuse as more particularly set forth in that order which also set forth conditions for reinstatement. On April 3, 1996 Dr. Eskin, accompanied by Dr. David Canavan of the Physicians Health Program (PHP), appeared before a committee of the Board and reviewed her participation in the PHP and her treatment with Neal A. Shore, M.D., a psychiatrist, and Beth Rosenwasser, M.Ed., C.A.C. The committee, having been satisfied that Dr. Eskin has complied with the Board's order and that her treatment and her apparent recovery indicated that she may, with certain conditions, safely return to the practice of medicine and the Board, on this committee's recommendation having so found,

It is on this 15th day of July, 1996 ORDERED:

1. Dr. Eskin's license to practice medicine and surgery shall be and hereby is reinstated on the following terms and conditions:



- a. Dr. Eskin shall maintain absolute abstinence from mood-altering chemicals unless appropriately prescribed by her treating physician for a legitimate medical illness with documentation provided to the PHP;
- b. Dr. Eskin shall continue participation in the PHP on a schedule to be determined by the Medical Director of the PHP;
- c. Dr. Eskin shall continue counseling as indicated by the therapists who are involved in her care;
- d. Dr. Eskin shall submit to random urinalysis, on a schedule to be determined by the Medical Director of the PHP based on the duration and success of her recovery;
- e. Dr. Eskin shall direct and cause to be submitted periodic reports to the Board on her continued compliance and immediate notification of any evidence of a relapse.

2. Prior to any practice of medicine or surgery Dr. Eskin shall secure the Board's approval of the position, employment or practice setting where the practice will take place. Written notice shall be given to the Board's president, or such other individual as may be designated to act by the President, of any position, employment or practice setting in which the practice of medicine will be undertaken. The Board's president, or a designee thereof, shall review said notice, and if satisfied that compliance herewith has been demonstrated, and that the undertaking is

appropriate, he may approve Dr. Eskin's practice in the designated position, employment or practice setting, provided, however, under no circumstances shall Dr. Eskin be permitted to practice as an anesthesiologist.
