This matter was opened to the New Jersey State Board of Pharmacy upon the receipt of information that Abdul Rashid Chaudhry, husband of Samina Chaudhry who is the owner of Montgomery Pharmacy, Inc., pled guilty to the charge of distribution of a prescription legend drug. On or about November 2, 1994, Mr. Chaudhry, who is not a licensed pharmacist, dispensed a prescription legend drug from the drug inventory of Montgomery not pursuant to a valid prescription and without a license to engage in the practice of pharmacy.

Respondent being desirous of resolving this matter without the necessity of further formal proceedings, and having agreed to abide by the terms of the within Order, and for good cause shown,

IT IS THEREFORE ON THIS <sup>11th</sup> DAY OF Dec, 1996,  
ORDERED AND AGREED:

1. No later than January 31, 1997, Samina Chaudhry shall divest herself of all interest which she presently holds in Montgomery Pharmacy, Inc. to a person unrelated to her through consanguinity or marriage or to an entity in which none of the equity holders are related to her through consanguinity or marriage. Respondent shall provide the Board with a copy of the executed contract of sale.

2. In the event that respondent is unsuccessful in transferring ownership of Montgomery Pharmacy Inc. to an applicant that is acceptable to the Board by January 31 1997, respondent shall surrender the permit to the Board and discontinue all practice of pharmacy by midnight of January 31, 1997 and close Montgomery Pharmacy to the public pursuant to the requirements set forth in N.J.A.C. 13:39-1 et seq.
