This matter was opened to the New Jersey State Board of Psychological Examiners ("Board") upon receipt of information which disclosed that Judith Kabus, Ph.D., may have engaged in the unlicensed practice of psychology in violation of N.J.S.A. 14B-1 et seq., in connection with forensic evaluations. The parties being desirous of resolving this matter without recourse to formal proceedings and Judith Kabus, Ph.D., voluntarily submitting to the jurisdiction of the Board for the purpose of entering the within Order, and for good cause shown;

IT IS ON THIS 15th DAY OF MAY, 1998,


HEREBY ORDERED AND AGREED THAT:

1. Judith Kabus, Ph.D., shall cease and desist from engaging in any representation that she is a licensed practicing

psychologist, using a title or description, including the term "psychology," any of its derivatives, such as "psychologist" or "psychological" or modifiers such as "practicing" or "certified," in a manner which would imply that she is licensed under the Practicing Psychology Licensing Act, or offering to practice psychology as defined in the Act, except as otherwise permitted by N.J.S.A. 45:14B-6 and 8. The "practice of psychology" is defined at N.J.S.A. 45:14B-2(b) to mean the rendering of professional psychological services to individuals, singularly or in groups, whether in the general public or in organizations, either public or private, for a fee, monetary or otherwise. "Professional psychological services" means the application of psychological principles and procedures in the assessment, counseling or psychotherapy of individuals for the purposes of promoting the optimal development of their potential or ameliorating their personality disturbance and maladjustments as manifested in personal and interpersonal situations. Within the meaning of the Act, professional psychological services does not include the application for a fee, monetary or otherwise, of psychological principles and procedures for purposes other than those described above.

2. In the event the Board receives any information after the entry of this Order disclosing that Dr. Kabus has engaged in the unlicensed practice of psychology as defined herein, she shall be deemed a subsequent offender. Any such violation will

result in an application in Superior Court by the Attorney General
for an injunction and fines.


