Re: Cemetery Salesperson License

Dear Ms. Watson:

This is to advise you that the New Jersey Cemetery Board has reviewed certain information regarding activity in which you were engaged as a Cemetery Salesperson Licensee. The Board's initial review disclosed what appears to be the following violation:

N.J.S.A. 8A:9-5 Unlicensed cemetery salesperson; violation

You are hereby offered the opportunity to settle this matter and avoid the initiation of formal disciplinary proceedings by signing and returning the enclosed certification and paying the following:

\$250.00 penalty imposed by the Board

Alternatively, you may waive your right to a hearing and submit a written statement or explanation to the Board. The Board will consider this statement and render a final decision.

You may also request a hearing in which case the matter will be scheduled and this notice will serve as a complaint. At the hearing, you may, either personally or with the assistance of an attorney, submit such testimony or other evidence as you may deem necessary in order for the Board to finally determine whether the unlawful acts alleged herein have been proven. Please be advised that if you request a hearing, the Board will not be bound to the

terms stated in this letter, and may, after presentation and evaluation of all the evidence presented, impose any of the sanctions contained in N.J.S.A. 8A:10-1. You should also be aware that the Board may assess civil penalties in an amount greater than that herein offered in settlement.

Additionally, the Board may, if the facts are found to so warrant, enter an order requiring restoration of any monies acquired by lawful acts, requiring payment of all costs involved in this matter, and directing you to cease and desist from the continued practice of acts found to be unlawful by the Board.

The enclosed certification should be returned to the Board with your indicated course(s) of action within ten (10) days following receipt hereof. In the event that the Board receives no response within ten (10) days, the allegations contained herein shall be deemed admitted and the Board will proceed to finally review the matter and enter an appropriate final order in relation thereto.
