This matter was opened to the New Jersey State Board of Veterinary Medical Examiners (hereinafter "Board") upon the receipt of information indicating that Sambhu Ghosh, DVM had been hired by Luv My Pet MVS II, P.C. to participate in a vaccination clinic at the Watchung, New Jersey store of Petco. Based on investigation and on the testimony of Dr. Ghosh before the Board on March 22, 2000, the Board finds that Dr. Ghosh prepared inadequate patient records in that he failed to record any normal signs on the patient record, nor did he record the weights of ferrets; he maintained no patient records in his possession; he conducted inadequate physical examinations in that Dr. Ghosh admitted that the examinations were quick and he looked only for obvious signs and not all animals were weighed prior to administering medication which is based on the weight of the animal; he had no branch office license displayed at the location; and he failed to establish acceptable patient/client/veterinarian relationships.

Dr. Ghosh, wishing to resolve this matter without further proceedings and without the filing of a formal complaint, and the Board being satisfied that this Order is adequately protective of the public health and welfare,

IT IS on this 26th day of July, 2001,

ORDERED that Respondent shall henceforth cease and desist from those practices above found to be unlawful;

ORDERED that Respondent shall pay to the Board the amount of \$400.00 in civil penalty by certified check or money order within ten days of receipt of this Order. Such payment shall be delivered or mailed to: Executive Director, State Board of Veterinary Medical Examiners, 124 Halsey Street, 6th floor, Newark, New Jersey 07102;

ORDERED that Respondent shall pay to the Board the amount of \$114.00 in costs by certified check or money order within ten days of receipt of this Order. Such payment shall be delivered or mailed to: Executive Director, State Board of Veterinary Medical Examiners, 124 Halsey Street, 6th floor, Newark, New Jersey 07102.
