This matter was opened to the New Jersey State Board of Examiners of Electrical Contractors upon receipt of complaints filed by five individuals who alleged that Respondent had contracted to perform electrical contracting services, received money in advance in deposit for performing those services, and then failed to complete the work contracted for. In addition, on at least one occasion Respondent failed to reply to a letter from the Board investigating a complaint.

Inasmuch as both the Board and respondent are desirous of

resolving this matter without litigation, and to satisfy the grievances of complainants, and for good cause shown:

IT IS ON THIS 19 DAY OF September, 2001  
HEREBY ORDERED AND AGREED THAT:

1. Respondent shall agree to a public reprimand, based on his violation of his duty as a licensee to cooperate with Board investigations, N.J.A.C. 13:45C-1.2 and -1.3, and based on his having engaged in occupational misconduct pursuant to N.J.S.A. 45:1-21.

2. Respondent agrees to undertake, or assures that he has already undertaken, the following actions, with regard to the complainants:

a) Horst Savickas: forward to the attention of Barbara Cook, Board of Examiners of Electrical Contractors, P.O. Box 45006, 124 Halsey Street, 6th Floor, Newark, NJ 07171, a total of \$2,500. Payments are to be in the form of a certified check or money order, made payable to Horst Savickas, on the following schedule: \$500 to be paid before the end of September, 2001; further payments are to be made on the 15th of each month, beginning on October 15, 2001, in the amount of \$500 each month, until the entire amount is paid.

b) Andrew Roberson: Send a copy of the cancelled check of

the return payment to Mr. Roberson of \$225, to the attention of Barbara Cook at the above address, within 30 days from the date of the signing of this Order.

c) Deborah Terry: Send a copy of a letter to the local inspector, requesting an inspection in this matter, to the attention of Barbara Cook at the above address.


d) Helen Sanders: Send a copy of whatever papers have been served upon Respondent in this matter to the attention of Barbara Cook at the above address within 30 days of the signing of this Order. In addition, Respondent undertakes to pay any judgment rendered against him by any court of limited jurisdiction in this matter, within 30 days of the date said judgment is rendered. A copy of the judgment is to be forwarded to the attention of Barbara Cook at the above address within ten days of any decision rendered.


e) Irving Huffin: Send a copy of final inspection in this matter within 30 days of the signing of this Order to the attention of Barbara Cook at the above address. Should it be impossible to obtain final inspection, due to no fault of Respondent, Respondent is to inform the Board at once of this situation, and forward proof to the Board that he has made a good faith effort to obtain inspection.

3. Failure to comply with the terms of this Order within the time limits set forth will be viewed as a violation of this

Order, subject to civil penalties pursuant to N.J.S.A. 45:1-21(e)  
for professional misconduct.
