



psychotherapy services to N.O.'s minor child on a regular basis in the State of New Jersey. Dr. Ciliotta readily admits to the facts described above, but she neither admits nor denies any violation of the laws of this State.

The parties being desirous of resolving this matter without recourse to formal proceedings in the Superior Court of New Jersey for the unlicensed practice of psychology and Dr. Ciliotta voluntarily submitting to the jurisdiction of the Board for the purpose of entering the within Order, and for good cause shown;

IT IS ON THIS 24<sup>th</sup> DAY OF JANUARY, 2002,

HEREBY ORDERED AND AGREED THAT:

1. Claire A. Ciliotta, Ph.D., shall cease and desist from engaging in the practice of psychology as defined in N.J.S.A. 45:14B-2(b), including any representation that she is a licensed practicing psychologist in this State. Further, pursuant to N.J.A.C. 13:42-1.6, Dr. Ciliotta shall not be eligible to be employed in an exempt setting as defined in or to qualify for practice under N.J.S.A. 45:14B-6, except by further order of this Board.

2. Dr. Ciliotta shall make restitution to N.O. for fees paid in the amount of \$1,900.00 and to G.B. (N.O.'s former husband) in the amount of \$2,300.00. Such restitution shall be paid by certified check or money order made payable in the name of each individual and submitted to the Board at 124 Halsey Street, Sixth

Floor, Newark, New Jersey 07102, no later than thirty (30) days from the entry of this Order.

3. Dr. Ciliotta shall be assessed a civil penalty in the amount of \$13,000. This civil penalty shall be paid by certified check or money order made payable to the State of New Jersey and submitted to the Board at 124 Halsey Street, Sixth Floor, Newark, New Jersey 07102. Dr. Ciliotta shall be permitted to pay the civil penalty in installments. The first installment in the amount of \$2,000.00 shall be submitted no later than thirty (30) days from the entry date of this Order. Thereafter, Dr. Ciliotta shall make eleven monthly payments in the amount of \$1,000.00 each, no later than the first business day of each month. The first monthly payment shall be due and payable on March 1, 2002. Any failure to make a timely payment shall be deemed a violation of this Consent Order and shall cause the entire remaining balance of the civil penalty to become immediately due and payable.

4. Dr. Ciliotta shall pay the costs of the investigation of this matter in the amount of \$3,166.33. This amount shall be submitted to the Board also payable to the State of New Jersey no later than thirty (30) days from the entry date of this Order.

5. Dr. Ciliotta shall not be permitted to submit a work sample for the purpose of pursuing licensure in this State by way


of oral examination any sooner than June 1, 2002 and until the restitution has been paid as ordered herein.

6. In the event the Board receives any information after the entry of this Order disclosing that Dr. Ciliotta has engaged in the unlicensed practice of psychology in this State, she shall be deemed a subsequent offender. Any such violation will result in an application in Superior Court by the Attorney General for enforcement of this Order, an injunction, and fines.


