Administrative Action

CONSENT ORDER

This matter was opened to the New Jersey State Board of Chiropractic Examiners (hereinafter "the Board") upon receipt of information that Dr. Lowenstein (hereinafter "Respondent") may have failed to maintain appropriate patient records in connection with his practice at 321 Mantoloking Road, Brick, New Jersey.

On December 7, 2000, Respondent appeared, together with counsel, Anthony F. La Bue, Esq., and Susan Fruchtman, Esq., at an investigative inquiry held by the Board into the matter. Having reviewed the entire record, including the testimony of Respondent at the investigative inquiry, it appears to the Board that the Respondent did, in certain instances, fail to maintain appropriate patient records which accurately and adequately documented the care provided to his patients on each visit, including but not limited to their examinations, treatment, re-examinations and

billing. This failure was in violation of N.J.A.C. 13:44E-2.2 and is a basis for disciplinary action pursuant to N.J.S.A. 45:1-21(h). It appearing however that Respondent desires to resolve this matter without recourse to formal proceedings, and for good cause shown:

IT IS ON THIS *22<sup>nd</sup>* DAY OF *February*, 2002  
HEREBY ORDERED AND AGREED THAT:

1. Respondent shall successfully complete and pass twelve (12) hours of continuing education in Record Keeping. These courses shall be completed within 12 months of the entry of the within Consent Order. Respondent shall secure prior approval of the Board for the specific courses proposed to satisfy this requirement. Respondent shall be required to complete the attached Continuing Education Proof of Attendance Report as proof of successful completion and passing of the required course work. The attached forms are made a part of the within Consent Order, and a separate form is to be used for each course.


2. Respondent shall cease and desist from violations of N.J.A.C. 13:44E-2.2;

3. Respondent shall pay a civil penalty, pursuant to N.J.S.A. 45:1-22 and N.J.S.A. 45:1-25, in the amount of \$2,000.00 for failing to create and maintain contemporaneous, permanent records for all patients of the chiropractic services provided, and the billings made, to patients and/or insurance carriers. Payment for the civil penalties shall be by certified check or money order made payable to the State of New Jersey, and shall be sent to: Kevin B. Earle, Executive Director, Board of Chiropractic Examiners at 124 Halsey Street, Sixth Floor, P.O. Box 45004, Newark, New Jersey 07101 no later than ten (10) days from the entry of this Consent Order. Subsequent violations will subject Respondent to enhanced penalties pursuant to N.J.S.A. 45:1-25.

4. Respondent is hereby assessed the costs to the State of the investigation in this matter in the amount of \$159.00. Payment for the costs shall be submitted to the Board by certified check or money order made payable to the State of New Jersey no later than ten (10) days from the entry of this Consent Order. Payment shall be sent to Kevin B. Earle at the address described in paragraph #3.

5. Failure to comply with any provisions of this Order or remit any and all payments required by this Order will result in the filing of a certificate of debt and may result in subsequent disciplinary proceedings for failure to comply with an Order of the Board.
