Administrative Action

ORDER FOR SURRENDER
OF LICENSE

This matter was opened to the New Jersey State Board of Pharmacy by receipt of information alleging that on or about March 6, 2002, respondent admitted to diverting Vicodin, a Schedule III CDS, for his own use, from the active drug stock of his employer, Neighbor Care Pharmacy, while on duty as a pharmacist. In lieu of a proceeding to temporarily suspend respondent's license to practice pharmacy pursuant to N.J.S.A. 45:1-22, respondent, without

admitting to any of the allegations, has voluntarily agreed to refrain from further practice of pharmacy and to surrender his original certificate and license renewal pending further order of the Board.

ACCORDINGLY, IT IS on this 10th day of July, 2002,

ORDERED AND AGREED, pending further order of the Board, that the license of Damion Chmelewski to practice pharmacy in the State of New Jersey is hereby suspended, and it is further


ORDERED AND AGREED, pending further order of the Board, respondent shall cease and desist from engaging in the practice of pharmacy including the following: respondent shall not handle, order, inventory, compound, count, fill, refill or dispense any drug; he shall not handle anything requiring a prescription including devices and medications; he shall not handle prescriptions; he shall not advise or consult with patients, and he is prohibited from being present within a prescription filling area of a pharmacy, and it is further,

ORDERED AND AGREED, pending further order of the Board, that respondent shall by execution of the within Order surrender his original wall certificate, his wallet certificate, and his most recent renewal card of his license to an authorized representative of the Board, and it is further


ORDERED AND AGREED, upon application for reinstatement, respondent shall submit documentation satisfactory to the Board

inclusive of, but not limited to, weekly random, witnessed urine screens, complete treatment records of all diagnostic and rehabilitative therapy and an in-depth, current evaluation from a Board approved psychiatrist or psychologist.
