This matter was opened to the New Jersey State Board of Pharmacy upon receipt of information that respondent has been arrested for the issuance of fraudulent prescriptions to obtain Vicoprofen, a Schedule III CDS, for his own consumption and that respondent has admitted to having a substance abuse problem. It appearing that in lieu of a proceeding to suspend respondent's license to practice pharmacy pursuant to N.J.S.A. 45:1-22,

respondent, without admitting to any of the allegations, and having voluntarily refrained since February 24, 2003 from the practice of pharmacy, has agreed to surrender his original certificate and license renewal pending further order of the Board,

IT IS THEREFORE on this *28th* day of *April*, 2003,

ORDERED AND AGREED, pending further order of the Board, that the license of Peter Mikhail, R.P. to practice pharmacy in the State of New Jersey is hereby surrendered, and it is further

ORDERED AND AGREED, pending further order of the Board, respondent shall cease and desist from engaging in the practice of pharmacy including the following: respondent shall not handle, order, inventory, compound, count, fill, refill or dispense any drug; he shall not handle anything requiring a prescription including devices and medications; he shall not handle prescriptions; he shall not advise or consult with patients, and he is prohibited from being present within a prescription filling area of a pharmacy, and it is further,

ORDERED AND AGREED, pending further order of the Board, that respondent shall, simultaneous with the execution of the within Order surrender his original wall certificate, his wallet certificate, and his most recent renewal card of his license to an authorized representative of the Board, and it is further


ORDERED AND AGREED, upon application for reinstatement, respondent shall submit documentation satisfactory to the Board

inclusive of, but not limited to, weekly random witnessed urine screens for a minimum of 12 months, complete treatment records of all diagnostic and rehabilitative therapy and an in-depth, current evaluation from a Board approved psychiatrist or psychologist.
