This matter was opened to the New Jersey State Board of Respiratory Care upon the review of information submitted which alleged that Jennifer Burns had engaged in the practice of respiratory care at Virtua West Jersey Hospital/Voorhees Division (Virtua) and Voorhees Pediatric Health System (Voorhees Pediatric) in Voorhess, New Jersey, from August 2002 through April 2003, after the expiration of her license on March 31, 2002, in violation of N.J.S.A.45:14E-9 and N.J.A.C. 13:44F-9.1, thus providing grounds for disciplinary action pursuant to N.J.S.A. 45:1-21(h). Ms. Burns should have been aware that her license expired on March 31,

2003 and that she could not practice as a respiratory care therapist until her license was properly renewed.

The Board having considered the aforesaid information, and the parties being desirous of resolving this matter without the necessity for further formal proceedings, Ms. Burns having waived any right to a hearing in this matter, and the Board finding that the within Order is adequately protective of the public health and that good cause exists for its entry:

IT IS ON THIS 9th DAY OF June, 2003,

ORDERED:

1. Jennifer Burns is hereby REPRIMANDED for engaging in or the unlicensed practice of respiratory care; and
2. Jennifer Burns is hereby assessed civil penalties in the amount of \$350.00 which she shall pay within thirty (30) days of her tendering of a signed copy of this Order, by certified check or money order payable to the State of New Jersey.
