**IT** IS on this 22<sup>nd</sup> day of October, 2004,


ORDERED that judgment will be entered as follows:




3. Any and all rights that Barry M. Vogel may have to seek any reinstatement of a medical license in the State of New Jersey are hereby extinguished.
