**INTERIM
CONSENT ORDER**

TO PRACTICE MEDICINE AND SURGERY
IN THE STATE OF NEW JERSEY

This matter was **opened** to the State **Board** of **Medical** Examiners (**hereinafter** the "Board") **upon** notification that Dr. **Flavius** Thompson had **been charged** with certain Third and Fourth Degree offenses arising **from conditions allegedly existent at his medical practice located** in Lakewood, New Jersey. Attorney General Peter **Harvey** by **Deputy Attorney** General Tara Adams Ragone has advised the **Board** of **his intention to seek Board** execution of an **Order to Shew Cause** requiring the doctor to **demonstrate** why the doctor's license **should** not be **temporarily** suspended pursuant to N.J.S.A. 45: 1-22 **pending** a plenary **hearing on the charges** to be embodied in a **Verified Complaint to be** filed

with the Board. Dr. **Thompson, through counsel**, has **advised** the Board that he **wishes** to resolve **this** matter on **an interim** basis with a **voluntary agreement to cease and desist** from practice **in** accordance with **the** terms of this Order.

The Board finding the within disposition adequately protective of the **public health, safety, and welfare,**

IT IS on this **24th** day of January, **2005**

ORDERED:

1. **Dr. Flavius Thompson shall immediately** voluntarily **cease** and desist from the practice of medicine at **any** location within the **State of New Jersey** and **shall** continue to **voluntarily** and **entirely** refrain **from practice** pending the **outcome of a** hearing before the **State** Board of Medical Examiners at its regularly scheduled **monthly** meeting **of February 9,2005.**
2. **Dr. Flavius Thompson hereby appoints** Robert Tarver, **Esquire as** his agent for **service** in this matter.
3. **The Attorney** General shall present for filing the Order to **Show Cause**, Notice of **Hearing, Verified Complaint, Letter Brief,** and supporting documents to the Board President **no** later than January 28,2005.
4. **Dr. Flavius Thompson, through counsel, shall file an Answer to** the documents **set** forth in paragraph three herein **no later** than February **7,2005** and **shall ensure** that a photocopy of that **Answer is** provided to **DAG Ragone** on that date.
5. **Dr. Flavius Thompson hereby represents and shall ensure that there shall be no** **medical** services offered **at any** location **at which** he presently **engages** in the practice

of medicine, **pending the order referenced in** paragraph **one** herein; **such** locations include, but **are** not limited to:

- a. **Pleasant Woman’s Pavilion and/or Shore Point OB-Gyn, P.C., a/k/a Share Point OB/GYN, Shore Point Obstetrics and Gynecology, P.C., Shore Point Birthing Center, 535 East *County Line* Road, Suite 15, Lakewood, New Jersey 08701-1428;**
- b. **890 West Bay Avenue, Barnegat, New Jersey 08005;**
- c. **Kimball Medical Center, Lakewood, New Jersey;**
- d. **Brick Hospital, Brick, New Jersey; and**
- e. **Southern *Ocean* County Hospital, Manahawkin, New Jersey.**


