CONSENT ORDER

TO PRACTICE ACCOUNTANCY IN THE
IN THE STATE OF NEW JERSEY

This matter was opened to the New Jersey State Board of Accountancy upon the receipt of a consumer complaint against Joseph Boscia, ~~X~~ P.A. After due consideration of the complaint and the response provided by Mr. Boscia, the Board issued a uniform penalty letter dated April 15, 2005, attached hereto and made a part of this Order.

Respondent, being desirous of resolving this matter, and the Board now having determined the allegations set forth in the penalty letter to be findings of fact, and respondent, in lieu of any further proceedings wishing to surrender his license as a ~~certified~~ public accountant in this State, has voluntarily surrendered his license.

LICENSED

ACCORDINGLY, IT IS THEREFORE on this 22 day of June, 2005, ORDERED AND AGREED:

1. Respondent's license to engage in the practice accountancy is hereby surrendered with prejudice to reinstatement.
2. Joseph Boscia shall cease and desist holding himself out to the public as a ~~Certified~~ ^{LICENSED} Public Accountant licensed in the State of New Jersey. Neither respondent nor his firm, shall hereafter use any business cards or stationery with letterhead indicating that he or the firm is licensed as a ~~CPA or a CPA firm~~ in this State, nor shall he or the firm represent to any member of the public that he or the firm is licensed in the State by use of the words ~~Certified~~ ^{LICENSED} Public Accountant(s), Public Accountant(s), Accountant(s) or any initials suggesting licensure.
