This matter was opened to the New Jersey State Board of Dentistry ("Board") upon receipt of information that Sheldon Waltuch, D.M.D. ("respondent"), an orthodontist, had permitted persons who did not hold requisite licenses or registrations to perform certain procedures in his dental office, including taking impressions, preparing teeth for bonding, and placing and removing wires.

Having reviewed the record, it appears to the Board that respondent permitted three employees who were not registered as dental assistants to engage in activities that are limited to person who hold such registrations.

These facts establish basis for disciplinary action pursuant to N.J.S.A. 45:1-21(e) and (h). It appearing now that respondent desires to resolve this matter without admissions and without recourse to formal proceedings and for good cause shown:

IT IS ON THIS 21 DAY OF December, 2005

HEREBY ORDERED AND AGREED THAT:

1. Respondent shall cease and desist from permitting persons who are not properly licensed or registered to perform duties outside their scopes of practice .

2. Respondent is assessed civil penalties, pursuant to N.J.S.A. 45:1-22 in the amount of \$5,000 for conduct with respect to allowing persons to perform activities outside their scopes of practice, to be paid no later than 30 days from the entry of this Consent Order. Payment for the civil penalties shall be submitted by certified check or money order made payable to the State of New Jersey and shall be sent to Kevin B. Earle, M.P.H., Executive Director, Board of Dentistry, P.O. Box 45005, 124 Halsey Street, Sixth Floor, Newark, New Jersey 07101. Subsequent violations will subject respondent to enhanced penalties pursuant to N.J.S.A. 45:1-25.

3. Failure to remit any payment required by this Order will result in the filing of a certificate of debt.

4. Failure to comply with any of the terms of this consent order may result in further disciplinary action.
