This matter was opened to the New Jersey State Board of Medical Examiners upon receipt of an application for reinstatement of Schinita Melvin's (Respondent) license to practice athletic training in the State of New Jersey. Respondent's license to practice athletic training expired on January 31, 2005. Respondent practiced athletic training while serving as the athletic trainer for the South Brunswick Board of Education at the Crossroads Middle School from February 1, 2005 to November 21, 2005 with an expired license in violation of N.J.S.A. 45:9-37.37. Respondent's October 26, 2005 license was reinstated on November 22, 2005, upon the payment of the appropriate fees.

The Board having considered the aforesaid information, and the parties being desirous of resolving this matter without the

necessity for further formal proceedings; and Respondent acknowledging that she practiced athletic training in New Jersey after the expiration of her license as alleged above, and having waived any right to a hearing in this matter; and the Board finding that good cause exists for the entry of the within Order;

IT IS. THEREFORE ON THIS SEVENTH DAY OF February, 2006  
HEREBY ORDERED AND AGREED THAT:

1. Respondent, Schinita Melvin, is hereby reprimanded for the unlicensed practice of athletic training.

2. Respondent, Schinita Melvin, shall contemporaneously with the filing of this Order, pay a civil penalty in the amount of \$250.00 by certified check or money order payable to the Treasurer of the State of New Jersey and forwarded to Susan Gartland, Executive Director, Athletic Training Advisory Committee, 124 Halsey Street, 6<sup>th</sup> Floor, Newark, P.O. Box 46017, New Jersey 07101.
