This matter was opened before the Alcohol and Drug Counselor Committee of the New Jersey State Board of Marriage and Family Therapy Examiners (hereinafter "the Committee"), upon information that respondent was engaging in the independent practice of alcohol and drug counseling for a fee and was not licensed or certified by the Committee or any other mental health licensing board to engage in mental health counseling, in violation of N.J.S.A. 45:2D-8. Specifically, respondent provided the Committee with a copy of her business card which stated that she provided counseling services in the areas of alcohol and drug counseling and evaluations, anger management, urine screening, art therapy, family therapy, group therapy and individual therapy.

It appearing that the respondent desires to resolve this matter without further proceedings, and the Committee finding that the Consent Order to be adequately protective of the public interest, and other good cause appearing;

IT IS THEREFORE ON THIS 13<sup>TH</sup> DAY OF July, 2006

ORDERED:

1. Respondent shall immediately cease and desist from engaging in or advertising any mental health counseling, including but not limited to alcohol and drug counseling, marriage and family therapy and/or psychotherapy unless and until she is licensed or certified by the Committee or otherwise appropriately licensed in the State of New Jersey to provide mental health counseling services.
