THIS MATTER was opened to the New Jersey State Board of Medical Examiners ("Board") upon receipt of information that the Pennsylvania State Board of Medicine ("Pennsylvania Board") entered into a Consent Agreement and Order ("Consent Order") with the Respondent, which he executed on April 10, 2008.

CERTIFIED TRUE COPY

More specifically, the Pennsylvania Board determined that Respondent had violated 49 Pa. Code § 16.92(a)(1), (a)(12), (a)(3), and (a)(4) by: (1) failing to complete an initial medical history and physical examination on patients for whom he prescribed controlled substances; (2) failing to perform re-evaluations on patients for whom he had prescribed controlled substances; (3) failing to provide patient counseling regarding the condition diagnosed and the controlled substance prescribed; and (4) failing to keep medical records on patients for whom he prescribed controlled substances. As a result, the Consent Order and Agreement provided for a public reprimand and civil penalty of \$5,000.00.

As a result of the foregoing, the Board has determined that Respondent's acts giving rise to the Pennsylvania Consent Agreement and Order provide a basis for disciplinary action pursuant to N.J.S.A. 45:1-21(d) and (e).

IT NOW APPEARING that the parties wish to resolve this matter without recourse to formal proceedings; and that the Respondent hereby waives any right to a hearing in this matter; and the Board finding the within Order adequately protects the public's health, safety and welfare; and for good cause shown;


IT IS ON THIS 15TH day of OCTOBER, 2008, ORDERED AND
