Based on your function as Ms. Alvarado's direct supervisor and , as the Program Director for the Institute the Board determined to hold you responsible for the unlicensed clinical practice of Ms. Alvarado .

HEREBY ORDERED AND AGREED THAT

1. You are hereby assessed a civil penalty in the amount of \$500.00 and a reprimand for aiding and abetting the practice of clinical social work by Kim Lee Alvarado without a license at that time to do so . Said penalty shall be paid by certified check or money order made payable to the State of New Jersey and submitted to Kay K. McCormack, Executive Director, State Board of Social Work Examiners, PO Box 45033, New Jersey 07101, within fourteen days of the entry of the within Consent Order.
