This matter was opened before the Alcohol and Drug Counselor Committee of the New Jersey State Board of Marriage and Family Therapy Examiners (hereinafter "the Committee") upon review of information that respondent self-reported to the State Board of Social Work Examiners in her application for certification as a social worker. Respondent disclosed that from 2004 through 2005 she engaged in the practice of alcohol and drug counseling and was not licensed or certified by the Committee or any other mental health licensing Board to engage in mental health counseling, in violation of N.J.S.A. 45:2D-8.

Ms. Mauriello appeared before the Committee, with her attorney Stephen J. McGee on April 24, 2009 and admitted that she engaged in

alcohol and drug counseling in a private practice, Addictions Specialists, 122 Main Street, Newton, New Jersey, under the supervision of Glenard E. Burke, Sr. Mr. Burke is presently licensed as a Clinical Alcohol and Drug Counselor.

It appearing that the respondent desires to resolve this matter without further proceedings, and the Committee finding the Consent Order to be adequately protective of the public interest, and other good cause appearing;

IT IS THEREFORE ON THIS 16 DAY OF July, 2009

**ORDERED:**

Respondent shall immediately cease and desist from engaging in or advertising any mental health counseling, including but not limited to alcohol and drug counseling, marriage and family therapy, social work and/or psychotherapy unless and until she is licensed or certified by the Committee or otherwise appropriately licensed in the State of New Jersey to provide mental health counseling services.
