TO PRACTICE CHIROPRACTIC IN THE STATE OF NEW JERSEY	:	

This matter was opened to the State Board of Chiropractic Examiners ("Board") upon information that Gunnar M. Henning, D.C. ("Dr. Henning"), inappropriately exceeded professional boundaries on multiple occasions during 2006 to 2007 in his chiropractic office.

On October 2, 2008, the Board sent Dr. Henning a Uniform Penalty Letter ("UPL") imposing a formal reprimand, ordering him to cease and desist from engaging in any behavior of a non-professional nature, imposing a monetary penalty of \$2,500, imposing costs incurred by the Board in investigating and prosecuting this matter, and ordering him to complete a course in medical ethics.

Because Dr. Henning failed to respond to the UPL, the Attorney General filed a motion for default, which was heard by the Board on June 25, 2009. The Board denied the motion and, upon the appearance of counsel for Dr. Henning, ordered this matter to be scheduled for a plenary hearing.

In order to avoid further formal proceedings in this matter, Dr. Henning agrees to each and every term of this Final Consent Order. The Board has determined that the terms of this Final Consent Order are sufficient to protect the health, safety, and welfare of the public. For such reasons and other good cause shown,

IT IS, therefore, on this 9<sup>th</sup> day of September, 2009,

ORDERED THAT:

1. Gunnar M. Henning, D.C., is hereby reprimanded for violating N.J.S.A. 45:1-21(e) and N.J.A.C. 13:44E-2.3(g).
2. Dr. Henning shall cease and desist from any behavior of a non-professional nature.
3. Dr. Henning shall demonstrate successful completion of ~~a Board-approved course in ethics. Successful completion of the~~ Professional Renewal in Medicine Through Ethics ("PRIM-E") course, available from the Robert Wood Johnson Medical School, or the Professional Problem Based Ethics ("ProBE") course, available from The Ethics Group, may be deemed to satisfy this requirement. "Successful completion" means that Dr. Henning attended all sessions of the course, fully participated in the course, and


received a final evaluation of an unconditional passing grade. Dr. Henning shall submit to the Executive Director of the Board written verification of said successful completion of the course.

4. Dr. Henning shall pay a monetary penalty to the Board in the amount of \$2,500.00, and shall additionally pay investigative costs and attorneys' fees incurred by the Board in the amount of \$2,253.80, for a total of \$4,753.80. Payment may be made in twelve monthly installments of \$396.15, with the total amount due no later than one year from the entry of this Final Consent Order. The Board, in its sole discretion, may file a Certificate of Debt for the amounts due under this Final Consent Order, and the Certificate shall be discharged upon payment in full of all amounts required under this Final Consent Order. Payments shall be made by certified check or money order payable to the "State Board of Chiropractic Examiners" and delivered to the Executive Director of the Board.




