THIS MATTER was opened to the New Jersey State Board of Architects ("Board") upon receipt of information that on or about March 2, 2010 a "Judgment in a Criminal Case" was entered against the Respondent, Jose A. Izquierdo, R.A., in the United States District Court, District of New Jersey, at which time Respondent

plead guilty to "Making False Statements" in violation of 18 U.S.C. §1001. As a result, Respondent was placed on probation for three (3) years with certain terms and conditions.

As a result of the foregoing, the Board has determined that Respondent's criminal conviction provides a basis for disciplinary action against Respondent's New Jersey license to practice architecture pursuant to N.J.S.A. 45:1-21(f).

IT NOW APPEARING that the parties wish to resolve this matter without recourse to formal proceedings; and that the Respondent hereby waives any right to a hearing in this matter; and the Board finding the within Order adequately protects the public's health, safety and welfare; and for good cause shown;

IT IS ON THIS 10th day of JUNE, 2010, **ORDERED AND AGREED THAT:**

1. Respondent's license to practice architecture in the State of New Jersey shall be, and hereby is, suspended for a period of three (3) years, such suspension to be stayed and served as a period of probation.

2. Upon signing this Consent Order, Respondent shall pay a civil penalty of Five Thousand Dollars and 00/100 (\$5,000.00) by certified check or money order made payable to the "State of New Jersey" and forwarded to the State Board of Architects, 124 Halsey Street, P.O. Box 45029, Newark, New Jersey 07101.

3. Upon signing this Consent Order, Respondent shall pay investigative costs of Six Hundred Eight Five and 71/00 (\$685.71) by certified check or money order made payable to the "State of New Jersey" and forwarded to the State Board of Architects, 124 Halsey Street, P.O. Box 45029, Newark, New Jersey 07101.


4. During the probationary period, Respondent shall enroll in, and successfully complete, to the Board's satisfaction, a three (3) credit ethics course in a degree program accredited by the National Architectural Accrediting Board, which said course must be pre-approved by the Board. Respondent must be enrolled in the pre-approved course within one (1) year of the filing date of the Consent order. Prior to termination of the probationary period, Respondent shall provide proof of successful completion of the course. "Successful completion" means that Respondent shall attend all scheduled classes, pass any examinations and meet all other requirements in order to obtain a passing grade of "A", "B" or "C".

5. Respondent agrees that in the event he violates any provision of this Consent Order, or is determined to be in violation of his criminal probation, or any statute and/or regulation which the Board administers during this probationary period, then Respondent's license to practice architecture in the State of New Jersey shall be automatically suspended without a hearing for the remainder of the probationary period, in addition to any other limitations or restrictions as the Board deems

appropriate. Within five (5) days of notification of the suspension, Respondent may seek a hearing limited to the sole issue of violation of this Consent Order.


