This matter was opened to the State Board of Social Work Examiners ("Board") upon the application of Chinwe N. Duru for an initial license to practice social work. Respondent Robert Hodnett, was Ms. Duru's supervisor at Catholic Christian Diocese of Trenton in Trenton, New Jersey for a period beginning September 2008, according to the application submitted to the Board by Ms. Duru.

Having considered the entire matter, including the documents submitted by Ms. Duru and the respondent explaining Ms. Duru's job responsibilities at Catholic Christian Diocese of Trenton, the Board finds that respondent, as Ms. Duru's direct supervisor, permitted Ms. Duru to engage in functions that were within the scope of practice of clinical social work when Ms. Duru had no license to practice, in violation of N.J.S.A. 45:1-21(n), aiding and abetting the unlicensed practice of social work.

These facts establish a basis for disciplinary action pursuant to N.J.S.A. 45:1-21(n). It appearing that the respondent desires to resolve this matter without recourse to formal proceedings, and the Board finding the entry of the Consent Order to be in the public interest,

IT IS ON THIS DAY OF 2010,  
HEREBY ORDERED AND AGREED THAT


1. Respondent shall cease and desist permitting unlicensed persons to provide social work services, and shall ensure that all individuals whom she supervises are properly licensed as required by law.

2. Respondent is hereby assessed a civil penalty in the amount of \$500.00 for aiding and abetting the unlicensed clinical practice of Chinwe N. Duru. The penalty shall be paid by certified check or money order made payable to the State of New Jersey and submitted to J. Michael Walker, Executive Director, State Board of Social Work Examiners, PO Box 45033, New Jersey 07101, within fourteen days of the entry of the within Consent Order.
