The New Jersey State Board of Dentistry received information that Sholom M. Fuzailov, D.D.S. ("Dr. Fuzailov" or "respondent"), had been arrested in New York on September 18, 2006, on a charge of Falsifying Business Records in the Second Degree, a class A misdemeanor, in violation of New York Penal Law section 175.05(1). The misdemeanor complaint alleged that respondent entered false notes into the dental records maintained by his office, and then submitted those false notes to the New York State Department of Health in order to be paid for a procedure that he did not perform.

On December 5, 2006, respondent pled guilty to those charges, without modification, in the First District Court of Nassau County, State of New York, and was sentenced to three years of probation.

In May 2008, the New York State Education Department, Office of Professional Discipline, State Board of Dentistry, entered into a consent order with respondent for one specification of professional misconduct based on the criminal conviction. The terms of that order included a two year suspension of license, of which the first three months were to be served as an active suspension, and the remainder stayed and served as a period of probation. Respondent fulfilled the terms of the order.

These facts provide the bases for disciplinary action in this State pursuant to N.J.S.A. 45:1-21(b) as respondent has engaged in the use or employment of dishonesty, fraud, deception, misrepresentation or false pretense; N.J.S.A. 45:1-21(e) as respondent has engaged in professional misconduct as determined by the Board; N.J.S.A. 45:1-21(f) as respondent has pled guilty to a crime or offense involving moral turpitude and relating adversely to the activity regulated by the Board; and N.J.S.A. 45:1-21(g) as respondent has had his authority to practice dentistry suspended by another state for reasons consistent the Uniform Enforcement Act, N.J.S.A. 45:1-14 et seq. Respondent has successfully completed the terms of his criminal and administrative probation in New York.

The Board finds that this order is appropriate and adequately protective of the public health, safety, and welfare, and respondent has agreed to its terms, waiving any right to a hearing, and for good cause shown:

THEREFORE, IT IS on this 21st day of December, 2010,

AGREED AND ORDERED that respondent's license to practice dentistry shall be suspended for a period of one year, which suspension shall be stayed in its entirety and served as a period of probation.


