

The New Jersey Occupational Therapy Advisory Council reviewed information regarding the application of Colleen R. Gilmartin for a license to practice occupational therapy.

Ms. Gilmartin practiced under the supervision of Bonnie H. Mauer ("Ms. Mauer" or "respondent").

During that review, it was determined that Ms. Mauer supervised Ms. Gilmartin while Ms. Gilmartin was not licensed to practice occupational therapy in the State of New Jersey. Specifically, Ms.

Mauer failed to request evidence of licensure from Colleen <sup>Gilmartin</sup> ~~R. Martin~~ <sup>BHM</sup> who practiced occupational ~~therapy~~ <sup>therapy</sup> at the Union Board of Education from June 2009 until October 17<sup>th</sup>, 2009.

These facts provide a basis for disciplinary action as respondent's conduct constitutes aiding and abetting the unlicensed practice of occupational therapy in violation of N.J.S.A.: 45:1-21(n).


It appearing that the respondent desires to resolve this matter without further proceedings and the Council finding entry of the Consent Order to be in the public interest:

IT IS ON THIS 26<sup>th</sup> day of January, 2011,

**ORDERED** and **AGREED** that

Bonnie Mauer shall pay a civil penalty in the amount of \$500.00, for violating N.J.S.A.: 45:1-21 (n). The penalty shall be paid either certified check or money order made payable to the "State of New Jersey" and submitted to Laura L. Anderson, Executive Director, Occupational Therapy Advisory Council, PO Box 45037, Newark, New Jersey 07101, within thirty days of the date M. Mauer signs this order.


