**AMENDMENT TO CONSENT ORDER****Division of Consumer Affairs**

**WHEREAS** the New Jersey Division of Consumer Affairs, Office of Consumer Protection (“Division”), and A. Ferraro Movers, Inc. and Raymond Ferraro, individually (“Ferraro”) (collectively, the “Parties”) are parties to a Consent Order filed with the Division on October 3, 2011 (the “Consent Order”); and

**WHEREAS** the Division and Ferraro have agreed to modify the February, 2012 and March 2012 installment payments under the Consent Order;

**IT IS ORDERED AND AGREED** as follows:

1. Effective Date - This Amendment shall be effective on the date it is filed with the Division. Except as specified herein, this Amendment is not intended to supercede, negate or otherwise alter provisions of the Consent Order except as expressly set forth herein. Capitalized terms herein retain their meanings as defined in the Consent Order, except as expressly set forth herein.

2. Modification of Section 6 of the Consent Order - Settlement Amount - Subsections 6.9 and 6.10 required Ferraro to make installment payments of Two Hundred Fifty and 00/100 Dollars (\$250.00) by February 15, 2012 and March, 15, 2012. Since those installment payments will be modified, Sections 6.9 and 6.10 shall no longer be effective. Installment payments for February, 2012 and March 2012 will be modified to Two Hundred Twenty-Five and 00/100 Dollars (\$225.00) each and will be paid in one lump sum of Four Hundred Fifty and 00/100 Dollars (\$450.00) on or before April 15, 2012, in the manner set forth in Section 6.11 of the Consent Order.
