This matter was opened to the New Jersey State Board of Nursing (" Board") upon receipt of Devin D. Davis's application for licensure by examination dated July 18, 2011. Upon a review of the application, and the results of the Criminal History Background Check, it was ascertained by the Board that, although the applicant had checked "no" on her application and Criminal History Background Check forms with respect to any prior arrests or convictions, respondent had been convicted of two local

ordinance violations on March 23, 2005 and February 26, 2006, respectively. The applicant was fined \$685.00 for the first offense, and \$130.00 for the second offense. The earlier offense involved allegations of simple assault and related charges, which the applicant explained involved an overzealous attempt to recover a ring and other items taken from her by her housemates. The second offense, according to the applicant, involved using another person's identification to get into a night club. The applicant maintained that she checked "no" in response to the application questions because she believed the question only applied to felonies.

The Board finds that the applicant engaged in misrepresentation in violation of N.J.S.A. 45:1-21(b) with respect to her criminal history.

The Board having reviewed this matter, and having determined that the within Order is sufficiently protective of the public, in lieu of further proceedings, and for other good cause shown;

IT IS on this *9th* day of *July*, 2012

HEREBY ORDERED AND AGREED that:

1. A civil penalty in the amount of \$250.00 is hereby imposed for the applicant's violation of N.J.S.A. 45:1-21(b).
2. The applicant's application for licensure shall be granted upon payment of any applicable fees and upon receipt of proof of successful completion of the requisite examination, if

not already submitted.
