This matter was opened to the New Jersey State Board of Nursing ("Board") upon receipt of respondent's request for reinstatement of her nursing license. Respondent's license expired on May 31, 2012, and the Board has ascertained that respondent continued in employment as a nurse until November 30, 2012.

The Board finds that respondent's having engaged in the practice of nursing subsequent to the expiration of his nursing license constitutes the unlicensed practice of nursing in violation of N.J.S.A. 45:11-37 and 45:1-25.

The Board having determined that reinstatement of respondent's license to practice nursing is appropriate, and that the within Order

is sufficiently protective of the public, in lieu of further proceedings, and for other good cause shown;

IT IS on this 21<sup>st</sup> day of February, 2013

HEREBY ORDERED AND AGREED that:

1. Respondent's petition for reinstatement of her license to practice nursing in New Jersey is granted upon review and approval of a completed application for reinstatement along with the requisite fees, information and the required Criminal History Background Check.

2. Respondent is hereby assessed a civil penalty in the amount of \$250.00 for the violation of N.J.S.A. 45:11-37 and 45:1-25. Payment shall be in the form of a certified check or money order, made payable to the State of New Jersey, and shall be submitted simultaneously with this signed Order.
