This matter was opened to the New Jersey State Board of Nursing ("Board") upon receipt of Emily Arowosaye's (Respondent's) petition to reinstate her suspended license to practice as a Registered Professional Nurse in the State of New Jersey. Respondent also holds an active license as a Homemaker-Home Health Aide Program Instructor. By Final Order of Discipline filed on May 9, 2011, Ms. Arowosaye's license to practice nursing was suspended for two years and she was ordered

to take an ethics course. The Final Order of Discipline was based upon Respondent pleading guilty to third degree Medicaid Fraud. As the Director of Nursing of Be Kind Healthcare Services, owned by her husband, Respondent submitted or caused to be submitted Medicaid claims for health care services allegedly provided to Medicaid beneficiaries when the services were not provided to the intended Medicaid beneficiaries. Respondent willfully obtained benefits from Medicaid to which she knowingly was not entitled. Respondent states that she and her husband were fined \$800,000.

In her petition for reinstatement, Respondent accepts responsibility and maintains that her clerical staff made "errors/misdeeds" that she did not notice. She has successfully completed an ethics course and has been compliant with her criminal probation, which is due to expire on April 1, 2014. In accordance with the criminal court's directive, Ms. Arowosaye is making payments of \$100 per month towards her \$800,000 criminal fine.

The Board having reviewed this matter, and having considered the nature of the above conduct and intending to prevent the possibility of future occurrences, and the parties desiring to resolve this matter, and the Board having determined that the

within Order is sufficiently protective of the public, in lieu of further proceedings, and for other good cause shown;

IT IS on this 8th day of July, 2013

HEREBY ORDERED AND AGREED that:

1. Ms. Arowosaye's petition for reinstatement of her license to practice as a Registered Professional Nurse is hereby granted with the following limitations: Ms. Arowosaye shall be permanently precluded from all aspects of billing and shall not work in any area of nursing which involves billing for services she provides as a nurse (including, but not limited to home care, private duty, or visiting nurse). Additionally, Ms. Arowosaye shall be precluded from educating, teaching, or training others about billing, and from supervising others involved in billing.

2. Ms. Arowosaye shall provide a copy of this Consent Order to all nursing employers and ensure that they are aware of the limitations on Ms. Arowosaye's nursing practice at all times.

3. Any deviation from the terms of this Order without the prior written consent of the Board shall constitute a failure to comply with the terms of this Order. Upon receipt of any reliable information indicating that Ms. Arowosaye has violated any term of this Order, Ms. Arowosaye's license may be automatically suspended by the Board until further Order of the

Board. Within fifteen days following receipt of such notice, Ms. Arowosaye may request a hearing to contest the entry of such an Order. At any such hearing, the sole issue shall be whether any of the information received was materially false. In addition, the Board reserves the right to bring further disciplinary action upon receipt of any new information.
