This matter was opened to the New Jersey State Board of Nursing ("Board") upon receipt of respondent's request for reinstatement of her nursing license. Respondent's license expired on May 31, 2013, and the Board has ascertained that respondent continued in employment as a nurse until Present.

The Board finds that respondent's having engaged in the practice of nursing subsequent to the expiration of her nursing license constitutes the unlicensed practice of nursing in violation of N.J.S.A. 45:11-37 and 45:1-25.

The Board having determined that reinstatement of respondent's

license to practice nursing is appropriate, and that the within Order is sufficiently protective of the public, in lieu of further proceedings, and for other good cause shown;
