This matter was first opened to the State Board of Medical Examiners upon receipt of information that Cindy Gartmond M.D. had applied for an unrestricted medical license. Following her plea of guilty to insurance fraud, Dr. Gartmond agreed, by way of consent order filed in April 2007, to cease from the practice of medicine as a physician in the State of Georgia for sixty days, followed by probation for the period of time that she was serving a sentence of criminal probation, but in any event not

less than five years. Thereafter, Dr. Gartmond agreed to a voluntary suspension of her New Jersey license until her license in Georgia is reinstated without restriction.

On June 4, 2014, Dr. Gartmond appeared before a committee of the Board in support of her petition for unrestricted licensure and provided the State of Georgia's Public Order Terminating the Terms of the April 13, 2007 Consent Order. Dr. Gartmond is currently employed as a general pediatrician with a physician's group in Georgia. A letter of reference from a colleague describes her performance as a pediatrician as exceptional. This Board is not aware of any other disciplinary actions associated with Dr. Gartmond's license to practice medicine in any State.

The Board having determined that the within Order is adequately protective of the public health, safety, and welfare,

**IT IS ON THIS 27 DAY OF August, 2014
ORDERED:**

1. Cindy Gartmond, M.D. is hereby granted an unrestricted license to practice medicine and surgery in the State of New Jersey.

2. Cindy Gartmond, M.D. Respondent shall pay all reinstatement fees and submit proof of the necessary continuing

education credits and successfully complete all application requirements including a Criminal History Background Check prior to her license being reinstated.
