This matter was opened to the New Jersey State Board of Chiropractic Examiners upon receipt of information the Board has reviewed and the parties wishing to resolve this matter without further formal proceedings, hereby stipulate to the following facts and conclusions of law.

FINDINGS OF FACT

1. Respondent Gregory Frick, D.C. is a chiropractic physician in the State of New Jersey and has been a licensee at all times relevant hereto.

2. On April 6, 2013, Respondent placed an advertisement which identified Dr. Frick as a Chiropractic Neurologist, which he is not and that he practices Nutritional Medicine, which is not within the scope of practice for a Chiropractor.

CONCLUSION OF LAW

1. The Board finds that Respondent's advertisement in which he identifies himself as a Chiropractic Neurologist, which he is not, is a violation of N.J.A.C. 13:44E-2.1 (c) (1), (3) and (6).

2. The Board finds that Respondent's statement that he practices Nutritional Medicine, which is not within his scope of practice, is a violation of N.J.A.C. 13:44E-1.1(a).

IT IS Therefore, on this ^{23rd} DAY OF ^{October}, 2014


ORDERED AND AGREED THAT:

1. A civil penalty in the amount of Five Hundred Dollars (\$500) is provisionally imposed upon Respondent for his violation of N.J.A.C. 13:44E-2.1 (c) (1), (3) and (6) as well as N.J.A.C. 13:44E-1.1(a). Payment shall be made by certified check money order, wire transfer or credit card payable to "State of New Jersey", delivered or mailed to Lisa Tadeo, Executive Director, State Board of Chiropractic Examiners, 124 Halsey Street, Newark,

New Jersey 07101. Payment shall be made contemporaneous with the entry of this Consent Order.


2. Failure to comply with the provisions of this Order may result in subsequent disciplinary proceedings for failure to comply with an Order of the Board.
