ORDER

Belleville Pharmacy, LLC
N.J. CDS REG. # DO15417

*(formerly assigned to Rossmore Pharmacy, Inc.)*¹

This matter was opened to Steve C. Lee, Acting Director of the New Jersey Division of Consumer Affairs ("the Director") upon receipt of correspondence from the owners of Belleville Pharmacy, LLC requesting that New Jersey CDS registration number DO15417 be reinstated without restriction for the pharmacy located at 338 Washington Avenue, Belleville, New Jersey 07109.

In August 2014, following allegations of improper diversion, dispensing or distribution of prescription medications, including controlled substances, Vincent A. Cozzarelli, R.Ph., 50% owner of Rossmore Pharmacy, Inc., agreed to the temporary suspension of the New Jersey CDS registration

number D015417 assigned to Rossmore Pharmacy, Inc. located at 338 Washington Avenue, Belleville, New Jersey 07109.

The sale and transfer of Rossmore Pharmacy, Inc. was completed on December 26th, 2014, from Vincent and Ray Cozzarelli to Mirsada Petovic, Bogdan Bienko, Dominick Zinna, and Brian Pinto. The new owners submitted a Pharmacy Permit Application to the New Jersey Board of Pharmacy, and the change of ownership and of name was approved by the Board of Pharmacy in January 2015. The owners of Belleville Pharmacy have no relationship with the former owners of Rossmore Pharmacy, and Vincent Cozzarelli and his family retain no ownership interest in the pharmacy. The owners of Belleville Pharmacy own eight other pharmacies in New Jersey, all of which are in good standing.

Belleville Pharmacy, LLC has retained the pharmacy permit number previously issued to Rossmore Pharmacy, Inc., which is associated with New Jersey CDS Registration Number D015417.

I find that the concerns leading to the temporary suspension of NJ CDS Registration Number D015417, previously assigned to Rossmore Pharmacy, have been eliminated.

ACCORDINGLY, it is on this 6th day of March 2015,
