This matter was opened to Steve C. Lee, Acting Director of the New Jersey Division of Consumer Affairs ("the Director") upon receipt of correspondence from Vishalkumar Patel, R.Ph./Jai shri ganesh, LLC owner of We Care Pharmacy requesting that New Jersey CDS registration number D04316100 be reinstated without restriction for the pharmacy located at 3317 Sunset Avenue, Ocean, NJ 07712.

In December 2013, following allegations of failure to comply with the State requirements pertaining to controlled substances, Mark Forgang, R.Ph., owner of the previous pharmacy at the same location, agreed to the voluntary surrender of the

The sale and transfer of Reiter's Pharmacy was completed on November 18, 2014, from S. & J. Ventures, Inc. d/b/a Reiter's Pharmacy to Jai shri ganesh, LLC d/b/a We Care Pharmacy. The new owners submitted a Pharmacy Permit Application to the New Jersey Board of Pharmacy, and the change of ownership and of name was approved by the Board of Pharmacy in February 2015. The owners of Jai shri ganesh LLC d/b/a We Care Pharmacy have no relationship with the former owners of S. & J. Ventures, Inc. d/b/a Reiter's Pharmacy, and Mark Forgang, R.Ph. and his family retain no ownership interest in the pharmacy.

Jai shri ganesh LLC d/b/a We Care Pharmacy has retained the pharmacy permit number previously issued to S. & J. Ventures, Inc. d/b/a Reiter's Pharmacy, which is associated with New Jersey CDS Registration Number D04316100.

I find that the concerns leading to the temporary suspension of NJ CDS Registration Number D04316100, previously assigned to S. & J. Ventures, Inc. d/b/a Reiter's Pharmacy, have been eliminated.

ACCORDINGLY, it is on this 30<sup>th</sup> day of March 2015,

**ORDERED:**

1. New Jersey Registration Number D04316100, currently associated with Jai shri ganesh, LLC d/b/a We Care Pharmacy, located at 3317 Sunset Avenue, Ocean, NJ 07712 is hereby reinstated without restriction.
