ORDER

Buena Care Pharmacy, Inc.
N.J. CDS REG. # DO8039400

(CDS Reg. #formerly assigned to Shayona Pharmacy) ¹

This matter was opened to Steve C. Lee, Acting Director of the New Jersey Division of Consumer Affairs ("the Director") upon receipt of correspondence from the owners of Buena Care Pharmacy, Inc. requesting that New Jersey CDS registration number DO8039400 be reinstated without restriction for the pharmacy located at 147 Smith Street, Perth Amboy, New Jersey.

In December 2013, following allegations of improper diversion, dispensing or distribution of prescription medications, including controlled substances, Rita Patel, R.Ph., co-owner of Shayona Pharmacy, agreed to the voluntary surrender of the federal DEA registration number BS7719795 assigned to

Shayona Pharmacy located at 147 Smith Street, Perth Amboy, New Jersey. The surrender of the pharmacy's federal DEA registration resulted in the inactivation of the New Jersey CDS registration D08039400 issued to the pharmacy.

The sale and transfer of MIT Kishan, LLC d/b/a Shayona Pharmacy was completed on January 5, 2015, from MIT Kishan, LLC to Buena Care Pharmacy, Inc. The new owners submitted a Pharmacy Permit Application to the New Jersey Board of Pharmacy, and the change of ownership and of name was approved by the Board of Pharmacy in January 2015. The owners of Buena Care Pharmacy, Inc. have attested that they have no relationship with the former owners of MIT Kishan, LLC d/b/a Shayona Pharmacy, and Rita Patel and her family retain no ownership interest in the pharmacy.²

Buena Care Pharmacy, Inc. retained the pharmacy permit number previously issued to MIT Kishan, LLC d/b/a Shayona Pharmacy, which is associated with New Jersey CDS Registration Number D08039400. Buena Care Pharmacy, Inc. cannot obtain a federal DEA registration without first obtaining a NJ CDS registration.

I find that the concerns leading to the inactivation of NJ CDS Registration Number D08039400, previously assigned to MIT Kishan, LLC d/b/a Shayona Pharmacy, have been eliminated.

ACCORDINGLY, it is on this 30th day of April 2015,

1. New Jersey Registration Number D08039400, associated with Buena Care Pharmacy, Inc., located at 147 Smith Street, Perth Amboy, New Jersey is hereby reinstated without restriction.
