Re: Uniform Penalty Letter In Lieu of Formal
Disciplinary Complaint

Dear Ms. Levere:

This letter is to advise you that the New Jersey State Board of Marriage and Family Therapy Examiners (the "Board") has become aware that you reside in New Jersey and do not possess a license to practice as a Marriage and Family Therapist in New Jersey.

Accordingly, the Board is requiring that you not (1) advertise the performance of marriage and family therapy services in New Jersey; (2) represent yourself as a licensed marriage and family therapist in New Jersey; and (3) use the title or description of marriage and family therapist in New Jersey unless and until you demonstrate to the Board that you are providing those services as an employee of a bonafide community agency as required by N.J.S.A. 45:8B-6. If you demonstrate that you meet the requirements of N.J.S.A. 45:8B-6, you may then advertise that you provide marriage and family therapy services in New Jersey, but any advertisement by you must disclose your name and the fact that you are not licensed by the State of New Jersey in compliance with N.J.A.C. 13:34-3.4.

In order to avoid the Board filing a complaint against you, the Board is requesting that you complete the enclosed certification and return it to the Board within fifteen (15) days following your receipt of this letter.



The execution of this Certification by me should not be considered as an admission by me that I represented myself as a Licensed Marriage and Family Therapist in violation of any of the laws of the State of New Jersey.

I further certify that I will continue to provide Christian pastoral therapeutic counseling services, under the auspices of Pen Life Ministries, Inc./Counseling Education and Family Dynamics pursuant to my clerical ministerial credentials.


