SUPPLEMENTAL ORDER

---

WHEREAS this Board previously entered a Final Order Adopting in Part, and Modifying in Part, the Initial Decision of Administrative Law Judge Joanne Candido in this matter, which Final Order was filed on April 28, 2016; and

WHEREAS, within said Order, we ordered that Dr. Mehta be assessed an aggregate total of 25% of all costs and fees incurred in the investigation and prosecution of this matter, but deferred determination of the precise amount of all such costs and fees to first allow the Attorney General to submit a supplemental certification detailing all costs and attorney's fees incurred through April 13, 2016, and to thereafter afford respondent an opportunity to review said application and submit in writing any objections she may have had to the fee application; and

WHEREAS we received a supplemental certification of fees and costs from Senior Deputy Attorney General Joan D. Gelber, dated April 15, 2016, which detailed that the aggregate total of fees and

costs, to include attorney's fees, incurred in the investigation and prosecution of this matter was \$109,192.41; and

WHEREAS respondent did not submit any written objection to the Attorney General's costs and fees application; and

WHEREAS we have independently reviewed the Attorney General's application, and are satisfied that all attorney's fees and all costs sought are reasonable, both as to the hourly rates and the number of hours, and are otherwise satisfied that good cause exists to require that Dr. Mehta be assessed 25% of all of the costs and fees detailed in the certifications submitted by Senior Deputy Attorney General Gelber, representing an aggregate cost and fee award of \$27,298.10;

NOW THEREFORE IT IS on this 27<sup>th</sup> day of May, 2016


ORDERED:

Respondent Monica Mehta, M.D. is assessed \$27,298.10, representing 25% of the total costs and fees incurred in the investigation and prosecution of this matter. Payment of the assessed costs and fees shall be due and owing within ten days of the date of filing of this Order. Payment shall be made by certified check, bank check or money order (or any other form of payment acceptable to the Board). In the event payment is not timely made, a certificate of debt shall be filed in accordance

with N.J.S.A. 45:1-24, and respondent may be subject to such other actions as may be authorized by law.
