13:30-8.1 Fee schedules

(b) The biennial registration fees charged by the Board of Dentistry shall be the following:

i. Initial registration fee:

(1) If paid during the first year of a biennial renewal period \$280.00

(2) If paid during the second year of a biennial renewal period \$140.00

ii. Active registration renewal \$280.00

iii. Inactive registration renewal \$110.00

iv. Initial branch office registration, dentist:

(1) If paid during the first year of a biennial renewal period \$70.00

(2) If paid during the second year of a biennial renewal period \$35.00

v. Branch office renewal registration renewal, dentist \$70.00

2. Dental Hygienists:

i. Initial registration fee:

- (1) If paid during the first year of a biennial renewal period \$80.00
- (2) If paid during the second year of a biennial renewal period \$40.00

ii. Active registration renewal \$80.00

iii. Inactive registration renewal \$40.00

3. Registered Dental Assistants, Limited Registered Dental Assistants and Limited Registered Orthodontic Assistants:

i. Initial registration fee:

- (1) If paid during the first year of a biennial renewal period \$80.00
- (2) If paid during the second year of a biennial renewal period \$40.00

ii. Active registration renewal \$80.00
