# (G) Brian Doroshuk, gas piping, November 14, 2014, email

The Board responded that based on existing New Jersey HVACR and Plumbing Statutes and Regulations, gas piping must be installed by a Licensed Master Plumber or Licensed Master HVACR Contractor.

A homeowner may perform this work based on the regulation requirements, a resident of a single family dwelling; however, when doing so, the homeowner must obtain necessary permits and final inspections according to UCC Codes.

### (H) Brian Doroshuk, chimney service professionals, December 31 2014 email

Requirements for chimneys and service on chimneys are contained in the Uniform Construction Code (UCC) governed by the State in Trenton, NJ.
