THIS MATTER being brought before the Court by John J. Hoffman, Acting Attorney General of New Jersey, on behalf of Amy Kopleton, Acting Chief of the New Jersey Bureau of Securities ("Bureau" or "Plaintiff"), (Stacy-Ann T. Davy, Deputy Attorney General, appearing), seeking relief by way of temporary restraints pursuant to R. 4:52, based upon the facts set forth in the Verified Complaint and Certification of Rudolph G. Bassman filed herewith, and Plaintiff having made a prima facie case that the defendants have engaged in, are engaging in, and/or will continue to engage in acts or practices declared to be illegal or prohibited by the Uniform

Securities Law (1997), N.J.S.A. 49:3-47 et seq. (the "Securities Law") filed herewith; and that the defendants and nominal defendants have notice of this application, and that Plaintiff is entitled to relief sought against defendants and nominal defendants for good cause shown,

IT IS on the 23 day of Pecensy, 2013 ORDERED that defendants George John Bussanich, George Bussanich, Jr. and Metropolitan Ambulatory Surgical Center LLC, and nominal defendants Melanie Whitney, Kerry Ann Bussanich, Wilma Marie Bussanich, Bridgeview Physical Therapy LLC, Northeast Anesthesia Management Group, LLC, Palisades Rehab and Spinal Care Group, LLC, Metropolitan Sleep and Diagnostic Testing LLC, Palisades Anastesia Associates LLC, MGK Holdings and MGK Enterprises, Inc. appear and show cause before the Honorable Thomas M. Moore, J.S.C., Superior Court of New Jersey, Chancery Division, General Equity Part, Essex County, Robert N. Wilentz Court Complex, 212 Washington Street, 8th Floor, Newark, New Jersey 07102, on the heard, why an order should not be issued:

- preliminarily enjoining and restraining defendants George John Bussanich, George Bussanich, Jr. and Metropolitan Ambulatory Surgical Center LLC from engaging in the conduct set forth in the Verified Complaint;
- 2. preliminarily enjoining and restraining defendants George John Bussanich, George Bussanich, Jr. and Metropolitan Ambulatory Surgical Center LLC and such persons acting in concert or participation with them including, but not limited to, any agent, employee, broker, partner, officer, director or stockholder, as receive actual notice of this Order, by personal service or otherwise, from the issuance for sale, sale, offer for sale, solicitation, purchase, offer to purchase, promotion, negotiation, advertisement or

- distribution from or within the State of New Jersey, of the securities offered by defendants George John Bussanich, George Bussanich, Jr. and Metropolitan Ambulatory Surgical Center LLC and any other security as that term is defined in the Securities Law, in violation of N.J.S.A. 49:3-60, pending further order of this Court;
- preliminarily enjoining and restraining defendants George John Bussanich and George Bussanich, Jr. from effecting or attempting to effect transactions in securities from, in or within New Jersey without being registered as an agent and/or broker-dealer with the Bureau, in violation of N.J.S.A. 49:3-56(a);
- 4. preliminary enjoining and restraining defendants George John Bussanich, George Bussanich, Jr. and Metropolitan Ambulatory Surgical Center LLC from acting, from and within the State of New Jersey as: an agent as defined in N.J.S.A. 49:3-49(b); a broker-dealer as defined in N.J.S.A. 49:3-49(c); an investment adviser and/or an investment adviser representative as defined in N.J.S.A. 49:3-49(g); or from controlling or associating in any capacity with any broker-dealer or investment adviser doing business from, into or within the State of New Jersey, or from controlling an issuer, or acting as an officer, director, or manager of an issuer as defined in N.J.S.A. 49:3-49(h) whose securities are offered for sale and/or sold in New Jersey;

7. freezing the assets, real and personal, of defendants George John Bussanich, George Bussanich, Jr. and Metropolitan Ambulatory Surgical Center LLC, and nominal defendants Melanie Whitney, Kerry Ann Bussanich, Wilma Marie Bussanich, Bridgeview Physical Therapy LLC, Northeast Anesthesia Management Group, LLC, Palisades Rehab and Spinal Care Group, LLC, Metropolitan Sleep and Diagnostic Testing LLC, Palisades Anastesia Associates LLC [sic], MGK Holdings and MGK Enterprises, Inc. in which either or any of them, jointly and/or individually, hold a legal or equitable interest, subject to reasonable living and/or ordinary business expenses,

including and any and all bank accounts and/or brokerage accounts under their direct or indirect control, jointly or individually, in that such assets should not be disposed of, transferred, dissipated, encumbered, withdrawn, removed, or sold pending further order of this Court;

Center LLC, and nominal defendants Melanie Whitney, Kerry Ann Bussanich, Wilma Marie Bussanich, Bridgeview Physical Therapy LLC, Northeast Anesthesia Management Group, LLC, Palisades Rehab and Spinal Care Group, LLC, Metropolitan Sleep and Diagnostic Testing LLC, Palisades Anastesia Associates LLC [sic], MGK Holdings and MGK Enterprises, Inc. including, but not limited to, causes of action and all such assets obtained in the future, and undertake all actions necessary or appropriate to maintain optimal value of these assets, including the liquidation of any such assets;

- b. review all the books and records of and pertaining to defendants George John Bussanich, George Bussanich, Jr. and Metropolitan Ambulatory Surgical Center LLC, and nominal defendants Melanie Whitney, Kerry Ann Bussanich, Wilma Marie Bussanich, Bridgeview Physical Therapy LLC, Northeast Anesthesia Management Group, LLC, Palisades Rehab and Spinal Care Group, LLC, Metropolitan Sleep and Diagnostic Testing LLC, Palisades Anastesia Associates LLC [sic], MGK Holdings and MGK Enterprises, Inc., including and any and all bank accounts and/or brokerage accounts under their direct or indirect control, jointly or individually, and report to the Court within ninety (90) days of this Order:

- necessity and obtaining Plaintiff's consent, make application to the Court for an order, in accordance with the Rules of Court, permitting the retention of such professionals by the receiver;
- d. be held harmless from and against any liabilities, including costs and expenses of defending claims, for which the receiver may become liable or incur by reason of any act or omission to act in the course of performing the receiver's duties, except upon a finding by this Court of gross negligence or willful failure of the receiver to comply with the terms of this or any other order of this Court, regardless of the time when such claims are filed;
- e. continue to be compensated out of the estate of defendants George John Bussanich, George Bussanich, Jr. and Metropolitan Ambulatory Surgical Center LLC, and nominal defendants Melanie Whitney, Kerry Ann Bussanich, Wilma Marie Bussanich, Bridgeview Physical Therapy LLC, Northeast Anesthesia Management Group, LLC, Palisades Rehab and Spinal Care Group, LLC, Metropolitan Sleep and Diagnostic Testing LLC, Palisades Anastesia Associates LLC [sic], MGK Holdings and MGK Enterprises, Inc., their successors, subsidiaries and affiliates, and/or such funds as the receiver may recover;

- 14 of the New Jersey Statutes, Corporation, General, including, but not limited to, those set forth at N.J.S.A. 14A:14-1 et seq.; and

- 11. tolling the statute of limitations and/or the statute of repose retroactive to the date upon which this action is commenced by Plaintiff for purposes of preserving the estate's rights, through the receiver, to prosecute actions to void preferential transfers, to seek to set aside fraudulent transfers, and encumbrances pursuant to N.J.S.A. 14A:14-4 and N.J.S.A. 25:2-20 et seq., among other actions;
- 12. providing that any person with actual or constructive notice of this Order who aids, abets, counsels, commands or instructs any person or entity to perform any act prohibited by this Order shall be subject to punishment;
- 13. affording Plaintiff and affected third parties such other relief as the Court deems just and equitable; and
- 14. entering a case management order setting forth expedited discovery periods and such order shall not preclude Plaintiff from immediately issuing subpoenas and/or taking depositions of defendants, nominal defendants and third parties separate and apart from the receiver's depositions of defendants, nominal defendants and third parties.

- 17. violating the Securities Law;
- 18. effecting or attempting to effect transactions in securities from, in or within New Jersey without being registered as an agent and/or broker-dealer with the Bureau, in violation of N.J.S.A. 49:3-56(a);
- 19. acting, from and within the State of New Jersey as: an agent as defined in N.J.S.A. 49:3-49(b); a broker-dealer as defined in N.J.S.A. 49:3-49(c); an investment adviser and or an investment adviser representative as defined in N.J.S.A. 49:3-49(g); or from controlling or associating in any capacity with any broker-dealer or investment adviser doing business from, into or within the State of New Jersey, or from controlling an issuer, as defined in N.J.S.A. 49:3-49(h), whose securities are traded in New Jersey; and

- 30. hold all privileges available to defendants George John Bussanich, George Bussanich, Jr. and Metropolitan Ambulatory Surgical Center LLC, and nominal defendants Melanie Whitney, Kerry Ann Bussanich, Wilma Marie Bussanich, Bridgeview Physical Therapy LLC, Northeast Anesthesia Management Group, LLC, Palisades Rehab and Spinal Care Group, LLC, Metropolitan Sleep and Diagnostic Testing LLC, Palisades Anastesia Associates LLC [sic], MGK Holdings and MGK Enterprises, Inc. pursuant to N.J.S.A. 49:3-69(d), and be able to waive such privileges as the receiver deems appropriate in his or her sole judgment.

LLC, Northeast Anesthesia Management Group, LLC, Palisades Rehab and Spinal Care Group, LLC, Metropolitan Sleep and Diagnostic Testing LLC, Palisades Anastesia Associates LLC [sic], MGK Holdings and/or MGK Enterprises, Inc. and/or their counsel, giving the receiver permission to access all the real property owned, leased, managed, controlled by either or all of defendants George John Bussanich, George Bussanich, Jr. and Metropolitan Ambulatory Surgical Center LLC, and nominal defendants Melanie Whitney, Kerry Ann Bussanich, Wilma Marie Bussanich, Bridgeview Physical Therapy LLC, Northeast Anesthesia Management Group, LLC, Palisades Rehab and Spinal Care Group, LLC, Metropolitan Sleep and Diagnostic Testing LLC, Palisades Anastesia Associates LLC [sic], MGK Holdings and MGK Enterprises, Inc. in order to inventory the personal property of said defendants and nominal defendants, their successors, subsidiaries and affiliates;

And it is further **ORDERED** that pending the return date herein:


