### IV ANNOUNCEMENTS

Mr. DeMassi announced that he received a letter from the Governor re-appointing him to the board, however his term has not expired. Several other board members received the same letter and requested Executive Director Hsu to look into this matter.

Mr. Whang announced the following:

He recently attended the NCARB ARE Committee meeting in Miami, Florida. The current 9-division ARE will be consolidated into a 7-division exam by the year 2010. Approximate schedule for changes to be implemented is February 2004, February 2006 with the final version completed in 2010.

The number of volunteers to serve on ARE Committees has dropped. Any board member who knows of anyone interested in serving on an ARE Committee should contact Bob Boynton.

NCARB also is looking for recently licensed architects, who passed each section of the ARE on the first try, to participate in an ARE Pre-Test.

Executive Director Hsu announced the following:

NCARB will implement a \$35 fee, beginning July 1, 2003. This fee will be assessed when candidates make any changes to their previous ARE scheduled appointment.
