II OPEN PUBLIC MEETINGS ACT

The statement required by Chapter 231, public laws of 1975, the "Open Public Meetings Act," was read and it was announced that notice of this meeting was prepared in the office of the Board of Architects and mailed to the Secretary of State, the Newark Star-Ledger, the Trenton Times, the Camden Courier-Post, the Record and the Atlantic City Press.

III APPROVAL OF MINUTES

IV ANNOUNCEMENTS

Mr. Picatagi announced that he will be attending the CLARB Board of Directors meeting on December 2 & 3, 2016.

Mr. Zaccone announced that he and Executive Director Kirk attended the NCARB meeting in Columbus Ohio. Some of the issues discussed concerned the illegal practice of architecture; raising the amounts of fine/penalties; working closer with home improvement contractors; legislative impediments; length of time to have rules changed.

V OLD BUSINESS

A North Carolina - U.S. Supreme Court decision involving the powers of state boards At their July 2015 meeting, the Board was informed of the recent U.S. Supreme Court decision involving the powers of state boards. After some discussion, the Board unanimously voted to send a memo to the Director of Division of Consumer Affairs with their concerns regarding the US Supreme Court's decision. At the May 12, 2016 meeting, Mr. Kirk informed the Board that there is no new information from the Division of Consumer Affairs. However, there is discussion toward formulating a policy within the Division concerning this matter. The Board unanimously voted to express the Board's disappointment that the Division has not provided some direction as to the protection of the board member's position acting on behalf of the state and this Board. Also that none of the state boards are participating in the discussion toward formulating a policy within the Division. On June 9, 2016, the Board expressed their concerns with Matthew Wetzel, Assistant Deputy Director, Division of Consumer Affairs. On July 14, 2016, Mr. Kirk informed the Board that there is no new directive from the Division with respect to this matter. Mr. Zaccone reiterated the Board's disappointment that the Division has not provided some direction as to the protection of the board member's position acting on behalf of the state and this Board.

VI NEW BUSINESS

A Correspondence

Copy of an e-mail from Kevin J. O'Neill, attorney, who questions whether an architect is authorized to sign engineering designs and are there any circumstances under which an architect can prepare engineering drawings in New Jersey is attached for Board review.

ACTION: Mr. Zaccone motioned to send a letter to Mr. O'Neill advising that there is not enough information for the Board to reach a determination and that he should review of the scope of practice definitions for architects and professional engineers and apply that to the building design services act. Mr. Soriano seconded the motion. It passed unanimously.

B Landscape Architect Continuing Education course review A request for re-consideration for the following course was received and is recommended for three (3) hours:

Phytotechnologies: Using Plants to Clean Up Webcast

ACTION: Mr. Picatagi motioned that based on the information submitted the above course be approved for three (3) hours of continuing education credits. Mr. Soriano seconded the motion. It passed unanimously.

C Legislation

A-4273 which requires State supervison of certain professional and occupational licensing boards is attached for board review.

ACTION: Liza Ackerman, Regulatory Analyst, Division of Consumer Affairs was present for discussion of this Bill. The Board has concerns that the bill needs to provide immunity, and to clearly define immunity for board members and clarification of the workings of the process.
