OPEN MINUTES

I. Ratification of Minutes

A. November 28, 2005

A motion was made by Ms. Manista and seconded by Dr. King to accept the November 28, 2005 Open Minutes as presented. A vote was taken and the motion carried by a unanimous vote. The November 28, 2005 Open Minutes were ratified by the Board of Medical Examiners on January 11, 2006.

II. New Business

A. Senate No. 1276

(Synopsis - Revises procedures for suspension or revocation of licenses for overdue child support) - Introduced February 6, 2006

A motion was made by Ms. Manista and seconded by Dr. King to advise its Division of Consumer Affairs legislative liaison that the Committee supports S-1276. A vote was taken and the motion carried by a unanimous vote.

B. May 22, 2006 Athletic Training Advisory Committee Meeting

A motion was made by Dr. King and seconded by Ms. Manista to cancel the May 22, 2006 meeting due to lack of a quorum. June 26, 2006 is the next scheduled meeting date for the Athletic Training Advisory Committee. A vote was taken and the motion carried by a unanimous vote.

III. Old Business

A. Timothy Walsh, A.T.

Consent Order filed December 6, 2005

The Committee received and reviewed a copy of the Consent Order filed December 5, 2005 by the Board of Medical Examiners in the matter of Timothy Walsh, A.T. for violation of N.J.S.A. 45:9-37.37 as he practiced athletic training from the year 2000 through July, 2004 with an expired license. Mr. Walsh's license to practice

athletic training in the State of New Jersey was reinstated on July 30, 2004. The Committee is also in receipt of payment from Mr. Walsh in the amount of \$1,000.00 satisfying the civil penalty in this matter.

B. Cynthia Miller, A.T.

Consent Order filed December 5, 2005

The Committee received and reviewed a copy of the Consent Order filed December 5, 2005 by the Board of Medical Examiners in the matter of Cynthia Miller, A.T. for violation of N.J.S.A. 45:9-37.37 as she practiced athletic training from the year 1997 through April, 2005 with an expired license. Ms. Miller's license to practice athletic training in the State of New Jersey was reinstated on April 25, 2005. The Committee is also in receipt of payment from Ms. Miller in the amount of \$1,000.00 satisfying the civil penalty in this matter.

C. Anthony Brito, A.T.

Consent Order filed December 22, 2005

The Committee received and reviewed a copy of the Consent Order filed December 22, 2005 by the Board of Medical Examiners in the matter of Anthony Brito, A.T. for violation of N.J.S.A.45:9-37.37 as he practiced athletic training from February 1, 2005 through June 30, 2005 and from September 1, 2005 through September 21, 2005 with an expired license. Mr. Brito's license to practice athletic training in the State of New Jersey was reinstated on September 22, 2005.

Ratified by the Board of Medical Examiners 6/14/06 / AT Cmte. 6/26/06 Mr. Brito was also found in violation of N.J.S.A. 45:1-21(a) and (b) as he failed to disclose information pertaining to an arrest in 1994 on his initial application form and a second arrest in 2001 on his 2003 or 2005 renewal applications. The Committee is also in receipt of payment from Dr. Brito in the amount of \$270.00 satisfying the civil penalty in this matter.

D. Craig LaBianco, A.T.

Consent Order filed February 8, 2006

The Committee received and reviewed a copy of the Consent Order filed February 8, 2006 by the Board of Medical Examiners in the matter of Craig LaBianco, A.T. for violation of N.J.S.A. 45:9-37.37 as he practiced athletic training from June of 2004 to April of 2005 prior to being granted a license. Mr. LaBianco was granted a license to practice athletic training in the State of New Jersey on April 12, 2005. The Committee is also in receipt of payment from Mr. LaBianco in the amount of \$250.00 satisfying the civil penalty in this matter.

E. Kyu Lee, A.T.

Consent Order filed March 24, 2006

The Committee received and reviewed a copy of the Consent Order filed March 24, 2006 by the Board of Medical Examiners in the matter of Kyu Lee, A.T. for violation of N.J.S.A. 45:9-37.37 as he practiced athletic training from August, 2003 to September, 2005 prior to being granted a license. Mr. Lee was granted a license to practice athletic training in the State of New Jersey on September 20, 2005. The Committee is also in receipt of payment from Mr. Lee in the amount of \$320.00 satisfying the civil penalty in this matter.

F. Schinita Melvin, A.T.

Consent Order filed April 6, 2006

The Committee received and reviewed a copy of the Consent Order filed April 6, 2006 by the Board of Medical Examiners in the matter of Schinita Melvin, A.T. for violation of N.J.S.A. 45:9-37.37 as she practiced athletic training from February 1, 2005 to November 22, 2005 with an expired license. Ms. Melvin's license to practice athletic training in the State of New Jersey was reinstated on November 22, 2005. The Committee is also in receipt of payment from Ms. Melvin in the amount of \$250.00 satisfying the civil penalty in this matter.
