- A. Correspondence to the Advisory Committee from Eric Nussbaum, LAT, Athletic Trainers' Society of New Jersey (ATSNJ) seeking clarification for the term "referral" in the Athletic Training Regulations N.J.A.C. 13:35-10.6, addressing "Practice outside of schools and professional teams."
