III. New Business

A. Changes to the Division of Consumer Affairs Licensing Boards and Process
Effective August 1, 2014, the State of New Jersey and the Division of Consumer Affairs has, by statutory mandate, began enforcing a law that offers licensees of other states an expedient path to licensure in New Jersey.

THE COMMITTEE ACCEPTED THIS PROCEDURAL CHANGE AS INFORMATIONAL AFTER A MOTION BY MR. SENSOR AND SECOND BY MS. CAMILLONE.

B. A3804, Requires State agencies to periodically review administrative rules and regulations to ensure continued efficacy.
