Committee determined that the scope of practice regulation requires substantial changes. The Committee was advised that those changes cannot be made to the rule on adoption. Therefore, the Committee decided to propose the changes to the scope of practice regulation in a separate rulemaking that will appear in the New Jersey Register for public comment. After further review and discussion by the Committee members, a motion was made by Timothy Sensor and seconded by Karen Manista to approve the scope of practice regulations with amendments. Motion carried unanimously.
